Pursuant to Rule 706A of the Listing Manual of Singapore Exchange Securities Trading Limited, Singapore Telecommunications Limited (“**Singtel**”) wishes to announce the following transactions that occurred during the half year ended 30 September 2020:

Incorporation of Subsidiaries

Singtel has incorporated a subsidiary in Singapore known as Singtel Nex Pte. Ltd. (“**Singtel Nex**”). Singtel Nex has an issued and paid-up capital of S\$2 and its principal activity is investment holding. The directors of Singtel Nex are Chua Sock Koong and Lim Cheng Cheng.

Singtel Nex has incorporated a subsidiary in Singapore known as Singtel ATN Pte. Ltd. (“**Singtel ATN**”). Singtel ATN has an issued and paid-up capital of S\$2 and its principal activity is investment holding. The directors of Singtel ATN are Chua Sock Koong and Lim Cheng Cheng.

Singtel ATN has in turn incorporated a subsidiary in Australia known as Australia Tower Network Pty Ltd (“**Australia Tower Network**”). Australia Tower Network has an issued and paid-up capital of A\$2 and its principal activity is to hold telecommunications infrastructure and provide related services. The directors of Australia Tower Network are Kelly Bayer Rosmarin and Lim Cheng Cheng.
