Subject: Progress of Legal Dispute between AIS and NT (TOT) on porting of subscribers from 900 MHz system to 3G 2100 MHz

To: President

Reference: Letter to the Stock Exchange of Thailand No. AIS-CP 004/2019 dated February 22, 2019, on Progress of dispute between AIS and TOT on porting out of customers

Reference is made to the dispute that National Telecom Public Company Limited (“NT”) (formerly known as TOT Public Company Limited) filed to the Arbitration Tribunal in 2014, claiming damages from Advanced Info Service Public Company Limited (“AIS” or the “Company”) in porting of subscribers to Advanced Wireless Network Company Limited by having subscribers press *988* and claiming damages from May 2013 to September 2015 (the end of the concession agreement) in the amount of THB 32,813 million. NT claimed that the Company was in breach of the concession agreement. Subsequently, on February 21, 2019, the Company received a unanimous resolution dismissing NT’s claim, whereby NT filed a petition for revocation of the resolution to the Central Administrative Court on May 15, 2019.

The Company would like to inform that on September 22, 2023, the Central Administrative Court has dismissed NT’s petition for revocation of the resolution. However, NT is eligible to file an appeal to the Supreme Administrative Court within 30 days. If there is any significant update, the Company shall inform accordingly.
